son of Sylvester Greenlee and Esther Hetty Barnett, was born November 3, 1841, in Mason County, West Virginia; died September 5, 1922, in Fort Dodge, Webster County, Iowa, and is buried in the Coal Ridge cemetery, at Knoxville, Marion County, Iowa. On May 31, 1866, at Knoxville, Marion County, Iowa, he was married to SOPHIA MIRIAM EVERETT, who was born December 18, 1848, at Knoxville, Marion County, Iowa; died July 19, 1910, at Shawnee, Pottawatomie County, Oklahoma, and is buried in the Coal Ridge cemetery, at Knoxville, Iowa; she was the daughter of John Smith Everett and Elizabeth Ellen McCown.

Levi Thompson Greenlee worked with his father on the farm, receiving his education in the district schools during the winter months and by studying at home. In the spring of 1861 he commenced the study of medicine under Dr. Warren Day Everett. On October 28, 1861 he enlisted in Company I of the Fourth Iowa Volunteer Infantry, and served until July 24, 1865. He was with his regiment in its first battle at Pea Ridge, Arkansas, in March 1862, and in an engagement late in the afternoon of the second day of fighting was wounded in the left arm; however he did not leave the regiment and was detailed to assist the surgeons in caring for the wounded, and when the army moved he was left at Cassville, Missouri, in charge of the wounded of his regiment that were not able to be moved, with instructions to move them to Springfield, Missouri, as soon as they were able. On arriving at the general hospital at Springfield, by request of his wounded comrades, he was again detailed to care for them until they were able to be sent home on furlough. He rejoined his regiment at Vicksburg, Mississippi, and was with the regiment in all of its campaigns, including Sherman's march to the sea. On January 1, 1864, at Raleigh, North Carolina, he was promoted to the rank of sergeant. After the surrender of Lee, his regiment went across country to Washington, D. C. where they marched in the Grand
