On December 24, 1866, he was married to LUCINDA M. POTTER who was born June 4, 1839, at Strattanville, Clarion County, Pennsylvania, and died at that place August 30, 1873. In 1866 he was elected treasurer of Cologne district, and in 1880, he was elected County Commissioner, of Mason County, for a term of four years; in 1885 he was appointed deputy sheriff, in which capacity he served for twelve years. He was a Presbyterian.
