On October 27, 1895, at Waterloo, Mason County, West Virginia, he was married to IDA STEWART who was born November 28, 1869, at Stephens, Mason County, West Virginia; died March 1, 1937, at Gallipolis, Gallia County, Ohio, and is buried in the Mound Hill Cemetery. At the age of 17 he left school and took a job cutting timber, and thereafter for more than sixty years he was engaged in the timber and saw mill business. About 1896 he, in partnership with P. B. Buxton, rented and operated a flour mill at King's Landing, about two miles south of Leon, West Virginia. He lived at Arbuckle, West Virginia, during this period but later bought a farm near, what was then, Waterloo, Mason County, West Virginia, where all of his children were born. During this period he formed a partnership with Charles Buxton, and went into the saw mill and lumber business. This proved to be a successful partnership and lasted for more than eleven years under the name of Buxton and Riffle. His next business venture was with John F. Blessing and was not so successful. It failed in 1911, with a loss to Mr. Riffle of about ten thousand dollars. After this failure, he and his brother, Joseph Smith Riffle, went to Virginia and established a business known as the Covington Tie and Lumber Company. In 1914 he sold his farm at Waterloo, West Virginia and moved his family to Virginia, but the next year moved back to West Virginia, locating near White Sulphur Springs, in Greenbrier County. He remained in this vicinity, operating a saw mill for a number of years, but in 1921 moved to a farm in Gallia County, Ohio, and in 1925 located at Gallipolis, Ohio, where he still lives at 75 Cedar Street. He is a member of the Church of God, and attends church and Sunday School regularly. He has missed attending Sunday School only twenty times in the past twenty-five years. He is a Democrat; a member of the Knights of Pythias and the Independent Order of Odd Fellows.
